



2018 "Athletes' Rights" Issues

GOVERNANCE & ATHLETE REPRESENTATION "THEATRE"

- Does Athlete Commission truly represent all athletes?
- Can "internal" Athlete Commissions operate "independently"?

SAFESPORT & DUE PROCESS

- Athletes need protection from predators by sport governance administrators
- Sexual predators and abusers must be punished with appropriate due process
- Athletes, coaches and bystanders must be educated to provide appropriate assistance

COMPENSATION- LACK OF LIVING WAGE

- Corruption and self interest among sports administrators preventing flow through of financial resources to athletes
- Guaranteed compensation needed for all athletes (exceptions for highly compensated athletes)
- * Athlete pension plans needed (qualification criteria)


