
SCOTUS, Sports Gambling, & Anti-Commandering Murphy v. NCAA, 138 S.Ct. 1461 (U.S. May 14, 2018)

Professional and Amateur Sports Protection Act (PASPA) 25 USC § 2701 (1992)

- → unlawful for **State** [or person] "to sponsor, operate ... license ... betting ..." on competitive sporting events.
- → Grandfather Exceptions (Nevada +3*) 2012/2014 New Jersey authorized v. repeals law that outlawed sports gambling

Held (6-3): PAPSA is unconstitutional.

- → "Congress can regulate sports gambling directly, but if it elects not to do so, each State is free to act on its own."
- → States can not be commandeered to enforce a federal regulation.






