# National Sports law Institute 2007 Year in Review

During 2007, the NSLI and the Sports Law program at Marquette University Law School continued to provide diverse educational opportunities for Marquette law students as well as current and future leaders in the sports industry. In addition, through various publications and events, the NSLI has continued to provide a national forum for the thoughtful consideration and discussion of American and international sports law and business issues. # SPORTS LAW SCHOLARSHIP AND TEACHING COLLOQUIUM

On Thursday, September 27, 2007, the National Sports Law Institute of Marquette University Law School hosted a *Sports Law Scholarship and Teaching Colloquium* in Eisenberg Memorial Hall at the Law School.
