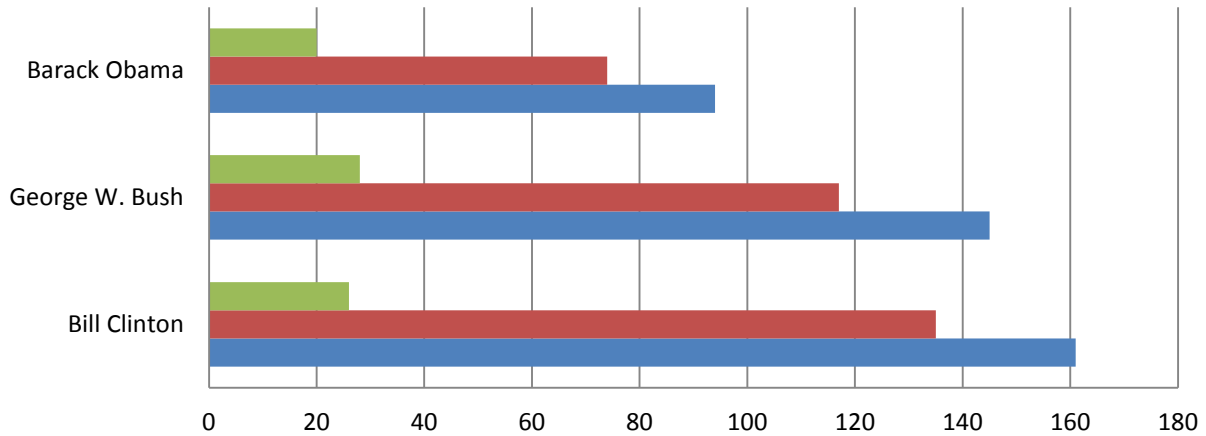


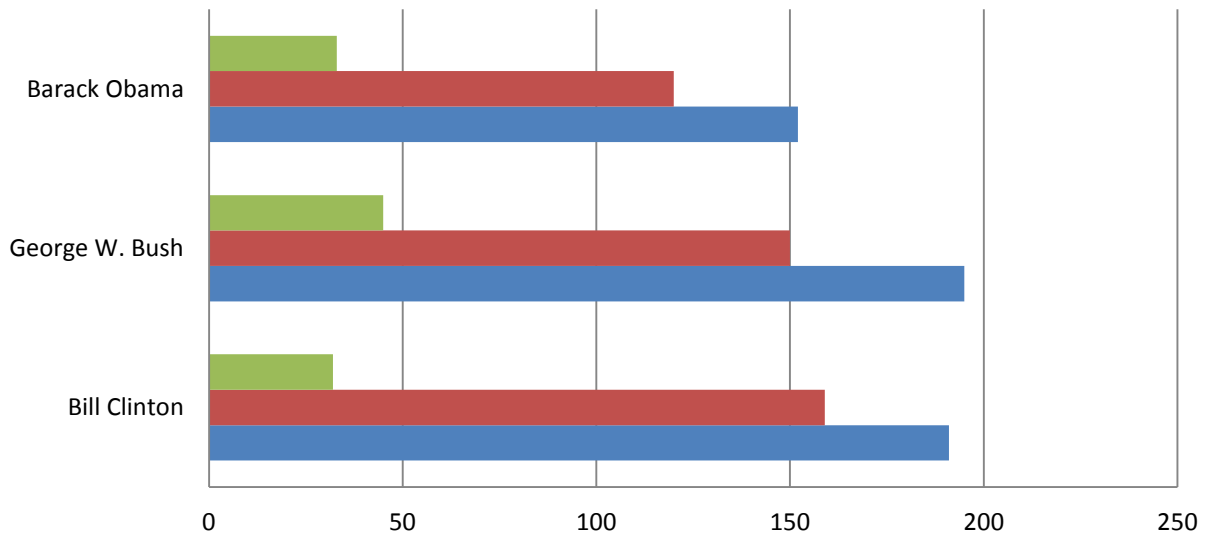

Federal Judicial Confirmations (9/19/11)



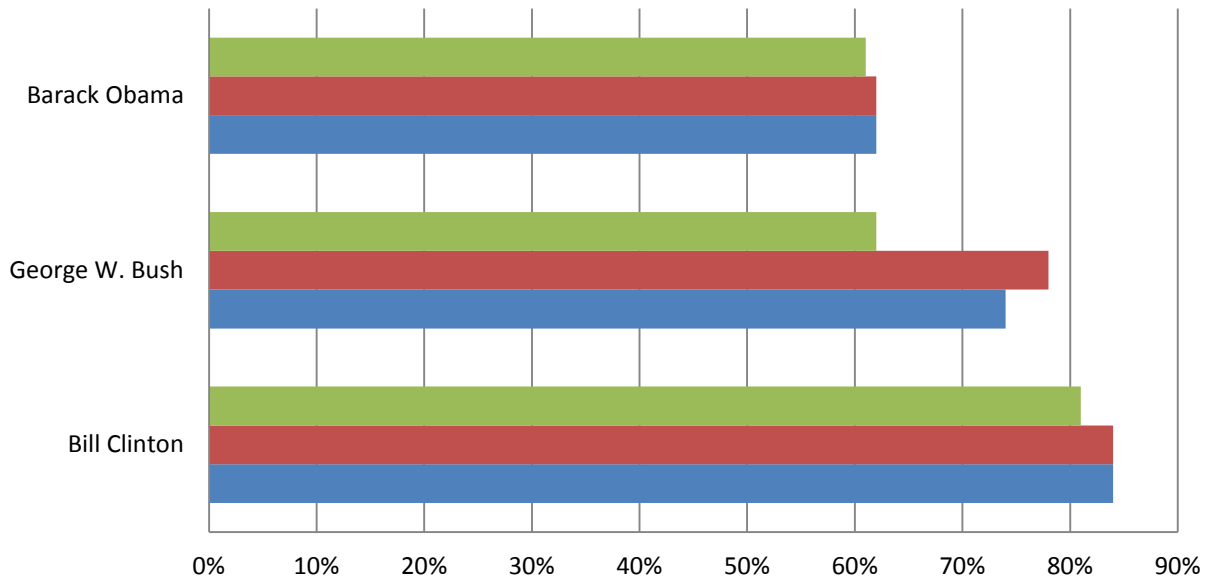
