

## Gregory J. Rahoi


1968-2006



Rahoi, 38, an FBI supervisory special agent, was killed Dec. 6 during a live-fire training exercise at Fort A.P. Hill, an Army base near Bowling Green, Va., about 60 miles south of Washington, D.C. A memorial was held Friday night in Brookfield for Rahoi, who was accidentally shot and killed during the training exercise. Rahoi began a life of public service as a firefighter and paramedic with the Town of Brookfield Volunteer Fire Department in the late 1980s, when he and Asselin met. Rahoi simultaneously earned his bachelor's degree in criminology and sociology at Marquette University, graduating cum laude with honors in 1989. He then went on to Marquette Law School, earning his law degree in 1993. That was followed by a one-year stint with the Shorewood Police Department and then duty as a police officer in Madison before joining the FBI in 1997. About three years ago, Rahoi was transferred to Virginia and the FBI's Hostage Rescue Team. The HRT, as it is sometimes called, is the agency's "primary unit responsible for counterterrorist operations," according to the FBI Web site. FBI Director Robert S. Mueller III posthumously awarded Rahoi the FBI Medal of Valor for "brave and heroic acts occurring in the line of duty while deployed to Iraq as a member of the Hostage Rescue Team," according to an FBI statement. Rahoi, Gregory J. Joined his "Baby Brother" John in Heaven on December 6, 2006 at the age of 38 years. Fond and devoted son of Natalie and Richard Rahoi. Treasured brother of Teri (Mike) Jansen. Adoring grandson of Veronica Tondryk. Fun loving uncle of Alyssa and Vicki. Fiance and true love of Special Agent Paula Paulk. Also remembered by other relatives, countless friends and his extended FBI family.

## Sheila R. Wasserman

1931-2010



Wasserman, Sheila Ruth, born in Boston, MA, April 22, 1931, to Patent Attorney Nathaniel P. Wharton and Deeda Levine Wharton. Died of cancer at home in Bayside, WI, December 10, 2010. Beautiful, gifted, adored wife for 54 years of Dr. Arthur Allen Wasserman. Attended Runkle Grade School and Brookline High School in Brookline, MA; studied two years at Smith College in Northampton, MA, as a Sophia Smith Scholar; completed her B.A. in History and Government, Magna Cum Laude and Phi Beta Kappa, at Radcliffe College in Cambridge, MA. Obtained her M.A. in Teaching at Harvard University with aid of a Ford Foundation Fellowship.. Taught Junior High School classes in Newton, MA, before marriage, and in Idaho Falls, ID, afterward. In Idaho, she also worked several years as TV's Miss Romper Room of Idaho Falls. Raised her two sons through early childhood in Pittsburgh, PA. Later served as News Reporter in Milwaukee, WI, where the family lived since 1968, except for three years in London, England, and one year in Birmingham, AL. In 1993, at age 62, she earned the Juris Doctor degree from Marquette University Law School in Milwaukee, having served as law intern for then Chief Judge of Milwaukee County Court and won the American Jurisprudence Award in Dispute Resolution. From 1994 to 2010, served at the Children's Court Center as defense counsel for juveniles, taking assigned cases from the Wisconsin State Public Defender Office. Was a member of the American Association of University Women, League of Women Voters, and Association of Women in Law. In 1992, was listed in Who's Who among Students in American Colleges and Universities.
