


Peter J. Bausch 1977-2014



While proud to be able to help the sick, she was most proud of her two sons, Kevin in Chicago, and Sean in Milwaukee. In the late 1990's, she was devastated by physical injuries, which subsequently prevented her from continuing to practice emergency medicine and treating patients. Despite painful and disabling injuries, Rachel pursued a legal career and graduated from Marquette Law School in 2004.

Curtiss Jason Stern's life on earth was taken prematurely at the age of 40 together with his life partner Jon Schlagenhaft, 50. Curt was born in Milwaukee on June 23, 1968, at Mount Sinai Hospital. He graduated from Hillel Academy, Brown Deer High School 1986, the University of Wisconsin-Milwaukee 1998, and Marquette University Law School 2002. Curt began his career early in his life working as a model. He was represented by Rosemary Bishop Talent Agency and Arlene Wilson Management. Curt had a strong entrepreneurial drive and business acumen. He started his first business, Saffi's Boutique in 1989 with long-time high school friend Lauren Taschen (nee Rutledge). Curt met Jon in 1987 and the two lived together as life partners for over twenty-one years and built their life and business together. Their French bulldog, Pudgie, and their Amazon parrot Beaker were the joy of their lives. He was co-owner and managing partner of Jon Schlagenhaft Design (JSD). Curt had an innate business sense and was a guiding force behind the business success of JSD. He managed the business and was a driving force that made JSD an internationally recognized design firm. Curt and Jon had a tremendous love and appreciation for the arts, and they were strong supporters of the Milwaukee community. They served on the board of the Florentine Opera and the Milwaukee Ballet.
