# **Group Study Rooms**

Eckstein Hall has 15 group study rooms designed for groups of law students to study or work together. Information regarding group study rooms, including how to reserve a room, can be found online at:

## **Guests/Visitors in Eckstein Hall**

- Guests of law students are welcome in Eckstein Hall.
- Guests must present a government-issued photo ID to the Welcome Desk, and the law student needs to be present when signing in a guest.
- Guests must follow Law School policies while in Eckstein Hall and may remain in the building when visitor hours have ended (Monday to Thursday at 8 p.m. and Friday, Saturday, and Sunday at 6 p.m.) as long as they are registered at the Welcome Desk and the registering law student is in the building.

# **Law Library**

The law library is fully integrated into Eckstein Hall in the northeast corner of all four floors, and library materials may be used anywhere in the building. If overnight use or use away from the general library space is anticipated, items should be checked out at the circulation desk on the first floor or at the self-checkout stations. The Law Library also provides access to many subscription databases that can be reached using the law library landing page or MARQCAT, the library catalog. Reference librarians and Circulation Desk staff are available to help during library service hours, which are posted online and at the Reference and Circulation desks. For help locating and using research resources as well as planning research strategies, students may contact a

reference librarian in person at the Reference Desk (on the first floor in the law library area near the windows), by telephone (414.288.3837), or by email (law.marquette.edu/law-library/ask-referencedesk). Students may also schedule Teams research consultations. For more information about the library, go to law.marquette.edu/law-library.

#### **Law News**

Law News is the Law School's internal digital publication through which the Law School sends announcements during the fall and spring semesters. Law News includes vital information regarding all aspects of student life—student organizations, academics, speakers/events, as well as research and scholarship opportunities—that are communicated only in this publication.

# Leaving Items at the Welcome Desk

Law students may not leave items at the Welcome Desk for pickup by others. If someone is picking up something from a student, the student must meet the person in the lobby to turn over the item.

#### Lockers

Lockers are available to law students on a first-come, first-served basis for a small fee. Requests are submitted by following the link on the student's profile page when logged into the Law School's website.

A locker will be assigned, and the combination to it will be available on your profile page within three business days of submitting the request.

## **Lost and Found**

Lost and found items can be claimed from suite 244. Items of value (i.e., cell phones, cameras, computers, IDs, etc.) can be claimed from the Student Affairs Office, suite 238. If items are not found in 238 or 244, individuals can check with the Welcome Desk, Tory Hill Café, the Circulation Desk, or MUPD. Unclaimed items will be donated or disposed of at the end of each semester.

#### Lubar Center

The Lubar Center is many things, but it is two in particular: a grand room in Eckstein Hall, serving as the site of community gatherings as well as the Law School's appellate courtroom, and shorthand for the school's Lubar Center for Public Policy Research and Civic Education. Through public programming such as the Marquette Law School Poll, On the Issues conversations with news makers, public lectures by scholars, conferences on issues of public importance, and heritage month dinners, MEDAL, and Summer Youth Institute, Marquette Law School-both inside and beyond the Lubar Center—seeks to serve as the region's leading venue for intelligent civil discourse about law and public policy matters. Law students, faculty, and staff are encouraged to attend programsand in fact are most welcome.



## **Marquette Today**

# Marquette University Identification Card (MUID)

An MUID is the key to Eckstein Hall. Students will need their MUID to:

- Enter through the security gates. Students who misplace their MUID need to stop at the Welcome Desk to sign in and present a government-issued photo ID.
- Obtain access to study rooms, classrooms, suite 342, the Fitness Center (once a Fitness Center Agreement has been completed), printers, and to check out materials from the library—including laptops, Mac chargers, and reserve items.
- Enter Eckstein Hall. Times change seasonally—check the webpage at

<u>law.marquette.edu/community/eckstein-hall-contact-and-hours</u>.

• Gain access to the third and fourth floors. While classes are in session, the third and fourth floors are open to the Marquette community and general public Monday to Friday, 7 a.m. to 4 p.m. After 4 p.m. Monday to Friday and all day on Saturday and Sunday, these floors are accessible only to the Law School community by using an MUID card. Dates and times are subject to change and will be communicated to the Law School community in *Law News*. During final exam and break periods, the third and fourth floors are accessible only to the Law School community by using an MUID card.

Please do not admit others onto these floors unless they are law students. Refer questions about accessing the third and fourth floors to the Welcome Desk.

• Students should go to the Welcome Desk or office 244B if their MUID is not working. Students who lose their MUID must purchase a new one at the Marquette Card Office, located in Union Station, first floor of the Alumni Memorial Union.

# Media and Technology

Located on the second floor in suite 218, the Media and Technology Group supports the Law School community in using audio/visual aids and other technology (e.g., computer software) for teaching and/or research. The purpose of the Media and Technology Group is to provide technical support to the students, faculty, and staff of Marquette University Law School. This support includes hardware and software installation, problem resolution, training coordination, and myriad informational services. # **Parking**

The Eckstein Hall parking structure policy serves two purposes: (a) to accommodate members of the public participating in Law School activities, with spaces allotted on a daily basis according to the number and type of Law School events; and (b) to offer parking on a first-come, first-served basis to Law School students and employees who have paid for University parking. Violation of policies can result in a fine or loss of parking privileges for an entire year. Simple policies to

be a happy Eckstein Hall–parking structure user include:

- Students must purchase a parking permit from Parking Services to have Eckstein Hall parking privileges. No one is assigned to the Eckstein Hall parking structure. When purchasing a permit, permit holders will be assigned to another lot on campus and can park in Eckstein Hall when permit spots are available.
- Eckstein Hall parking levels fill quickly. Students should arrive on campus with the expectation that they will park in their assigned lot on campus and walk to Eckstein Hall. This guarantees a timely arrival for classes.
- Church of the Gesu surface parking Lot J is NOT a Marquette Law School parking lot. Students who park there at any time (day or night) will be ticketed and may lose their Eckstein Hall parking privileges.
- When entering the Eckstein Hall parking structure, students should not pull a ticket unless they intend to pay for visitor parking. If student parking credentials are not working, the driver should back up and go to the driver's assigned lot. If unable to back up due to other cars in line, the driver should push the intercom button and follow instructions given by staff.
- Failure to exit within seven minutes of pulling a visitor ticket will require payment of the parking fee upon exiting.
- Idling outside of the parking structure to wait for a parking spot to become available is strictly prohibited.
   If no parking spots are available or the driver's parking credentials are not allowing access to the parking structure, the driver should proceed to park in the driver's assigned lot.



## **Parking continued**

- Please note that if parking credentials are not working, students will need to park in their assigned lot until the issue with their credentials can be resolved. Students can contact Parking Services at 414.288.6911 or <a href="mailto:muparking@marquette.edu">muparking@marquette.edu</a>, with their name, MUID number, and the type of permit they purchased for the semester, or they can report the issue to the Welcome Desk or office 244B.
- Students who have a University parking permit and handicap parking license or permit must alert the manager of building operations (office 244B) to receive special parking instructions.
- Complimentary weekend parking is available on both levels only to the Law School community. Students can use their MUID to scan in. (Do NOT pull a ticket.)
- No overnight parking is permitted on either parking level.
- Motorcycle parking is available in structures 1 and 2.

- Bicycle racks are available on both parking levels. Cyclists must provide their own locks.

Our door is always open during business hours, so please stop by and get to know the Law School's Student Affairs team.



## Student Kitchen

The student kitchen is located on the first floor in room 159.

- Refrigerators and microwaves are provided for student use. Students should label food containers with their names. The refrigerators are cleaned out the first Friday of each month. Unless otherwise communicated, all items in the refrigerator will be disposed of at that time.
- It is expected that kitchen users will clean up after themselves. Please be considerate of fellow students. Cover food when using the microwave and clean up any spills.

#### **Student Mail Folders**

Student mail folders—located on the second floor near the service elevator—should be checked regularly. They serve as a vital portal of communication among students, faculty, and staff.

## **Student Organization Suite**

All students are welcome to use suite 342 to study, relax, or work with a group. The suite also has a microwave and a refrigerator, in which students can store their food with the same policies as those for the Student Kitchen.

# **Tory Hill Café**

Tory Hill Café serves breakfast, lunch, and dinner with the added bonus of an espresso bar that serves up lattes and mochas. Hours change seasonally. People bringing their own lunches are welcome to eat in the Café. When the serving line is closed, the Café can be used as study space.

- Alcohol purchased in the Tory Hill Café must be consumed in the Café; alcohol served at events must stay within the program space.
- Pursuant to the university liquor license, bringing alcohol into Eckstein Hall is prohibited.
