On behalf of Marquette University Law School, we welcome all sixteen teams to the 69th Annual National Moot Court Competition, Region VIII. By now, you should have received a copy of the National Moot Court Competition Rules via email. First and foremost, please remember that briefs are due on **October 19, 2018 by 11:59 P.M. Eastern Time**. Each team must submit their brief via the Region VIII TWEN platform.

Each team has been assigned a team number below. You must use this number when introducing yourself to the court during oral argument or you will be penalized. Each competitor should introduce himself or herself to the court as Competitor A or Competitor B from his or her team. For example, the first competitor to speak from Chicago Kent College of Law I should introduce himself or herself to the Court as Competitor A from Team 101. Likewise, the second competitor from Chicago Kent College of Law I should introduce himself or herself as Competitor B from Team 101.
