2001 NSLI YEAR IN REVIEW

During the past year Marquette University Law School's Sports Law Program and the National Sports Law Institute furthered their mission by continuing to encourage the study of legal issues in amateur and professional sports, promoting informed and ethical practices in the sports industry, and serving as a resource for sports law students, attorneys and business professionals.

MASTER OF THE GAME AWARD DINNER

On Friday, November 16, 2001, the National Sports Law Institute hosted its sixth Master of the Game Award dinner honoring Secretary of Health and Human Services and former Governor of the State of Wisconsin, Tommy G. Thompson.

The night began with a reception for the approximately 280 attendees. The Master of Ceremonies, Ulice Payne Jr., a partner at Foley & Lardner and member of the Marquette University Board of Trustees, introduced Professor Matt Mitten, the Director of the National Sports Law Institute, and Marquette University Law School Dean Howard Eisenberg who both warmly welcomed Secretary Thompson and the dinner guests. Reverend Dan McDonald, S.J. then gave the invocation before dinner in the Grand Ballroom of the Pfister Hotel in downtown Milwaukee.

After dinner, Ulice Payne introduced a series of speakers who paid tribute to Secretary Thompson including: Robert Trunzo, the Vice President of the Lang Companies and Chairman of the Southeastern Wisconsin Professional

After the tributes, NSLI Director Matt Mitten and Martin Greenberg, the Chair of the NSLI Board of Advisors, presented the Master of the Game Award to Secretary Thompson for making significant contributions to the sports industry while serving as the Governor of Wisconsin and exemplifying the highest level of professionalism in his field.

The nation's leading advocate for the health and welfare of all Americans, Secretary Thompson has dedicated his professional life to public service. Born in Elroy, Wisconsin, Secretary Thompson began his career in public service in 1966 as a representative in Wisconsin's State Assembly. He was elected assistant Assembly minority leader in 1973, and Assembly minority leader in 1981. He began his tenure as Governor of the state of Wisconsin in 1987 and made state history when he was re-elected to office for a third term in 1994 and a fourth term in 1998. Confirmed by the Senate on January 24, 2001, and sworn in February 2, 2001, he is the 19th individual to serve as Secretary of Health and Human Services, which employs more than 60,000 people and has a fiscal year 2001 budget of \$429 billion.

Secretary Thompson was instrumental in acquiring public financing for Miller Park, the Milwaukee Brewers new stadium; the new Kohl Center and McClain Center at the University of Wisconsin; the Pettit Ice Center at State Fair Park, the soon to be renovated Lambeau Field - home of the Green Bay Packers - as well as legislation facilitating the construction of the Bradley Center.

Secretary Thompson has received numerous awards for his public service, including the Anti-Defamation League's Distinguished Public Service Award. In 1997, he received Governing Magazine's Public Official of the Year

Award, and the Horatio Alger Award in 1998. The Secretary served as chairman of the National Governors' Association, the Education Commission of the States and the Midwestern Governors' Conference. Secretary Thompson also served in the Wisconsin National Guard and the Army Reserve.



Intellectual Property Issues in Sports: Trademarks, Unfair Competition, and Athletes' Publicity Rights

On Friday, October 5, 2001, the National Sports Law Institute hosted its *Intellectual Property Issues in Sports: Trademarks, Unfair Competition, and Athletes' Publicity Rights* conference that was sponsored by the law firm of Foley & Lardner at Marquette University's Alumni Memorial Union.

The conference consisted of four panel discussions. The first panel considered "Marketing and Protection of Professional League and Team Intellectual Property Rights." Moderated by NSLI Director Matt Mitten, the panel included: Paula Guibault, the Senior Intellectual Property Counsel for the National Football League, who spoke about "Tackling A New Economy: The Legal And Marketing Challenges Facing Sports Licensed Properties In The Current Economy;" Jeff Pash, Executive Vice President and League Counsel for the National Football League who spoke on "Developments In Intellectual Property Law With A Focus On Satellite Television, Internet And Related Issues;"

and a joint presentation by Robert Du Puy, the Executive Vice President of Administration and Chief Legal Officer, Office of the Commissioner of Baseball, and a partner, Foley & Lardner, and Ethan Orlinsky, the General Counsel for Major League Baseball Properties, who spoke on "Legal Issues and Obstacles in Creating League-wide Internet/Interactive Ventures."

The second panel, which was moderated by Jeffrey Gewirtz, the Director of Legal Affairs for Meridian Management, SA, in Atlanta, discussed "Worldwide Enforcement of Intellectual Property Rights." It included Anne Wall, the Brand Protection Manager for the Salt Lake Organizing Committee of the Olympic Winter Games of 2002 who spoke on "The Game Behind The Game: Preventing The Misuse And Infringement Of Olympic-Related Marks And Copyrights;" John Cooper, Team Counsel and Assistant General Counsel for Turner Sports, who spoke on "The Role Of Sports Counsel In A Media Conglomerate;" and Ayala Deutsch, Senior Intellectual Property Counsel for the National Basketball Association, ended the panel with her presentation on "General Prosecution And Protection Efforts Of NBA Properties Internationally."

Associate Professor J. Gordon Hylton, a member of the NSLI's Board of Advisors, moderated the third panel titled Sponsorship and Player "Athletic Event Endorsements." The panel included John Collins, an attorney with Jenkins & Gilchrist in Chicago who spoke about "When Does A Collection Of Individuals Become A Separately Identifiable Group And Other Group Licensing Issues;" Pam Adolph, Assistant Vice-President of Licensing, Players Inc., who spoke about "Player Group Licensing And Related Issues In The NFL;" and Terry Prince, the Vice President of the Legal Department and Director of Legal Affairs for IMG Team Sports, who spoke on "Whose Face Is It Anyway? The Fine Line Between The First Amendment And The Right Of Privacy."

The final panel, moderated by Brian McNamara, from Foley & Lardner's Washington D.C. office, focused on "Protection and Enforcement of NCAA and University Marks." Panelists included Scott Bearby, Assistant General Counsel of the National Collegiate Athletic Association, who spoke on "Marketing, Protection and Enforcement of NCAA Marks;" Bill Hoye, Assistant Vice President and General Counsel for the University of Notre Dame, who spoke about "John Doe Restraining Orders & Enforcement: The Sweatshop Issue;" and Bruce Siegal, Vice President and General Counsel of the Collegiate Licensing Company, who spoke on "Protection and Enforcement Strategies for Collegiate Marks - CLC Consortium Perspective."

Thereafter, the Marquette University Law School's Sports Law Society hosted a reception for all attendees. SPORTS LAW CURRICULUM

A new course was added to the sports law curriculum at Marquette University Law School in the fall of 2001. Adjunct Professor Martin Greenberg taught a Sports Law Workshop titled "Sports Venues: From Election Day To Game Day." The course is dedicated to the study of the legal, financial, developmental, and political creation of sports facilities in the United States. The course examines the reasons for the stadium boom and proliferation of sports facilities in our country; the current debate over the use of public tax dollars underwriting sports venues; the ways in which sports facilities are financed and funded; the development process and the real estate implications of stadium creation; litigation challenging government participation in financing and referendums; the creation of public-private partnerships; relocation and retention issues; a review of the so-called facilities arms race in our universities; and trends for the future of stadium development. This new course can be taken to fulfill one of the requirements for the National Sports Law Institute's Sports Law Certificate.

STUDENT AWARDS & SCHOLARSHIPS

Francis D. & Jane Keogh Kelly Scholarship

The Francis D. & Jane Keogh Kelly Scholarship was established in 1997 to recognize a student in the Sports Law program at Marquette for his or her excellence in the study of sports law and service to the sports law program. The 2001-2002 recipient of the Scholarship is current *Marquette Sports Law Review* Editor-in-Chief, Ben Menzel.

Joseph E. O'Neill Prize for Student Writing

Each year since 1997, the Joseph E. Joseph E. Tierney, Jr. Award

This Award was created in 2000 in recognition of Joseph E. Tierney, Jr., a longstanding member of the NSLI's Board of Advisors and loyal supporter of the NSLI. The Award is given annually to the student in the Sports Law Program who graduates with the highest grade point average in sports law classes taken in partial fulfillment of the requirements for earning a Sports Law Certificate. Martin J. Greenberg Award

The NSLI established this Award in the fall of 1997 in honor of former NSLI Director Martin J. Greenberg. 
