
During the past year the National Sports Law Institute and the Sports Law Program at Marquette University Law School have continued to provide diverse educational opportunities for law students as well as current and future leaders in the sports industry, while also providing a national forum for the thoughtful consideration and discussion of American and International sports law issues.

THE EVOLVING NATURE OF HIGH SCHOOL, COLLEGE AND OLYMPIC SPORTS IN THE 21ST CENTURY

On Thursday, October 21 and Friday, October 22, 2004, the National Sports Law Institute hosted *The Evolving Nature of High School, College and Olympic Sports in the 21st Century* conference at the Hilton Milwaukee City Center in downtown Milwaukee. Conference sponsors included the law firm of Foley & Lardner, College Sports Inc., ScheerGame Sports Development, LLC and the Sports & Entertainment Law Section of the State Bar of Wisconsin.

The two-day conference featured several panels discussing cutting edge issues in amateur athletics from drug testing in sports to amateurism and gender equity. The conference began with a panel on Drug Testing in Sports. Moderated by NSLI Director Matt Mitten, Chair of the NCAA's Committee on Competitive Safeguards and



The second day of the conference began with a two part panel on Amateurism & Academics: Compatible or Conflicting Goals, moderated by C. Peter Goplerud, Dean & Professor of Law, Florida Coastal School of Law, Jacksonville, Florida. The first panel included: (1) Elsa Cole, General Counsel, NCAA, Indianapolis, Indiana, and tember of the NSLI's Board of Advisors, whose topic was In Defense of Amateurism;" (2) Shawn Eichorst, Senior Associate Athletic Director, University of South Carolina, Columbia, South Carolina, who discussed "Student Athlete Welfare vs. Student Athlete Exploitation;" and (3) Michael Marcil, Commissioner, Sunshine State Conference, Orlando, Florida, who spoke on "The Correlation Between Institutional Mission and NCAA Divisional Membership." The second panel included Martin Greenberg, Managing Director, College Town, LLC and a member of the NSLI's Board of Advisors, who discussed "The Collegiate Facilities Arms Race;" and (2) James McKeown, Partner and Chair, Antitrust Practice Group, Foley & Lardner, Milwaukee, Wisconsin, who spoke about "Sports & Antitrust: Defining the Procompetitive Benefits for Restrictions on Amateur Athletes."

After the final conference panel, attendees were invited to the Master of the Game luncheon honoring 2004 Master of the Game, Dr. Cedric Dempsey. The Master of the Game Award honors an individual who has made significant contributions to the sports industry and who exemplifies the highest level of professionalism in his or her field. Cedric Dempsey became the NCAA's third executive director on January 1, 1994. As president, Dr. Dempsey upervised a staff of 350 and provided leadership in the governance structure for the more than 1,200 colleges,

universities, conferences and affiliated organizations that comprise the Association.

In his time with the NCAA Dr. Dempsey facilitated the reorganization of NCAA Divisions I, II and III into a federated system and structured the Association so that Presidents now have legislative authority. He planned and administered the relocation of the NCAA from Kansas to Indiana. He organized key functions of the NCAA into new organizational units, established new goals for the NCAA Foundation and increased Foundation Board membership. Dr. Dempsey worked to provide students with a voice at the institutional, conference and national levels by establishing local, conference and national student athlete advisory committees and developed a public relations plan to help the general public understand the mission, goals and values of intercollegiate athletics programs.

Dr. Dempsey has always been committed to enhancing the principle of gender and diversity equity within any organization. In his time with the NCAA, the ethnic diversity of the management team increased from 8% to 22% and gender representation increased from 18% to 36%.

Prior to joining the NCAA in 1994, Dr. Dempsey was director of athletics at several universities, including the University of Arizona, the University of Houston, San Diego State University, and the University of the Pacific (California). Prior to serving in these positions, Dr. Dempsey was assistant director of health, physical education, recreation and athletics, assistant basketball coach, and a professor at Arizona. Dr. Dempsey was the head basketball, cross-country and tennis coach at Albion College in Albion, Michigan and served in various capacities at the University of Illinois, Champaign. In total, Dr. Dempsey has accumulated more than 40 years of experience in college athletics positions and organizations.

Dr. Dempsey earned a Bachelor of Arts degree from Albion College in 1954 and a Master's degree in Education from Albion in 1956. He received a Ph.D. from the University of Illinois in 1963.

After the Master of the Game luncheon, the NSLI hosted an "Ethical Issues in Sports & Entertainment Law Seminar," co-sponsored by the Sports & Entertainment Law Section of the State Bar of Wisconsin. After a welcome from NSLI Associate Director Paul Anderson, the Chair of the Sports & Entertainment Law Section, the first panel discussed Ethical Issues in Entertainment Law. The panel included moderator Jeff Tanner, attorney, Special Projects, Narada Productions, Inc. and secretary of the




AWARDS AND SCHOLARSHIPS
