The growing interaction between sports and the law has created a need for a greater understanding of the law as it relates to the sports world as well as an appreciation of the many ethical issues which are integral parts of this relationship.

THE INSTITUTE'S PRINCIPAL MISSION is to promote the development of ethical practices in all

is to promote the development of ethical practices in all phases of amateur and professional sports. The Institute aims to upgrade the level of information and education available to lawyers and sports industry personnel.

The Institute is served by a National Board of Advisors to provide direction to the Institute and to the Law School's curricular offerings in the sports law area. The Institute has received financial support from four founding sponsors: the Green Bay Packers of the National Football League, the Milwaukee Admirals of the International Hockey League, the Milwaukee Brewers of the American Baseball League, and the Milwaukee Bucks of the National Basketball Association.

Sports law is an amalgam of interrelated legal disciplines encompassing such areas as contracts, agency, torts, antitrust, labor, taxation and criminal law. For those interested in this somewhat specialized area, both curricular and co-curricular opportunities are offered. In order to assist students and sports-related professionals, the Institute serves as a repository of sports resource materials which include a sports law library and research center. The Law School offers elective courses to its students. One is entitled "Sports Industry Contracts and Negotiation," which focuses on professional athletes; another is "Regulation of Amateur Athletics" which deals with regulatory problems in amateur sports.

The Institute offers law students opportunities outside of the classroom. Students can serve as an institute research assistant as well as a legal intern with the Great Midwest Conference, assist in the publication of the NSLI newsletter For The Record, participate in the Sports Law Society, take part in the Institute's industry and community outreach programs, serve as a member of the NSLI "Sports Law" cable television show or become an editorial member of the Marquette Sports Law Journal. The Marquette Sports Law Journal is published by the Institute and Marquette University Law School and contains scholarly articles on significant sports law and business issues.



THE INSTITUTE IS COMMITTED TO SPORTS INDUSTRY OUTREACH PROGRAMS dedicated to those

INDUSTRY OUTREACH I KUJKRAMS dedicated to those in amateur and professional sports management, ownership and coaching positions. Presently, the Institute sponsors several such programs. The NSLI Sports Business Forum, which meets quarterly, provides an environment for discussion of current issues in sports, business and related matters. Past Sports Business Forum guest speakers have included Chicago Bulls and White Sox owner Jerry Reinsdorf, NCAA Executive Director Dick Schultz and National Football League Players Association General Counsel Dick Berthelsen. On an annual basis, the NSLI and Warner Cable present a sports excellence and achievement award to individuals who have demonstrated professional expertise in the sports industry and dedicated service to the public.

In addition, the Amateur Sports Law Center provides continuing education programs and seminars for attorneys, college and high school athletic directors, administrators and coaches. As a special endeavor, the NSLI delivered to the Milwaukee Public School system a risk management program for its sports personnel. This program provided instruction as well as a reference manual pertaining to athletic supervision, instruction, transportation and athletic codes of conduct. Moreover, the NSLI will assist in the creation of a practical two volume sports law textbook to be published by The Michie Company, a national legal publishing house.

The Institute is also involved in two special projects. In 1992, the NSLI, along with Sportsguide, Inc., will publish the first-ever **Sports Lawyer Directory.** This directory will list many of the attorneys who practice in this area and will list their specialty areas. In addition, the NSLI, in conjunction with the Marquette University Center for Ethics, will produce a manual containing legal and ethical commentary on sports industry practices.
