



## Motorsports

Kentucky Speedway alleges that NASCAR and ISC violated federal antitrust laws by illegally awarding NASCAR Nextel Cup Races to ISC. Similar restraints of trade claims have been made by Kentucky Speedway against NASCAR and ISC involving NASCAR's Busch Series and Craftsman Truck Series.
